3. All candidates who have been allocated a seat in any previous round of seat allocation and have joined/reported on allocated seats as per the procedure of joining/reporting & and holding the seat are not eligible for the stray round of counselling.
4. All participating candidates must carry original documents where accepting a seat will be treated as on-the-spot admission and original documents will be deposited on the spot. Non-joining on any accepted seat will lead to the imposition of a penalty as applicable to students resigning after admission.
5. Any candidate submits any document which is not valid as per the prospectus and any notice published will be treated as providing false information. For example
  - a) Submitting a document which is not issued between dates as prescribed in the prospectus and submitted by a candidate to obtain eligibility despite knowing the fact that certification is not valid as not issued as prescribed in the prospectus.
  - b) Applying in anticipation of obtaining the desired qualification and not obtained on the date as required.
  - c) False reporting on caste, age, gender, date of acquiring eligibility, and date of completion of the internship.
  - d) Any other information which is not true as required in the prospectus/ notice and submitted in order to dispute at a later stage.
6. If it is established, at any time during the process of Seat allocation of INI-CET January 2024 or later, that the applicant has deliberately furnished incorrect information for the purpose of falsification, it shall be treated as an attempt to cheat, and the candidature shall be annulled, and further legal and disciplinary actions will be taken.
7. Please review the INI-CET January 2024 prospectus for details regarding the rules, regulations and formats for submitting category certificates, applicable during the stray round counselling.
8. All candidates who would be allocated a seat in the stray vacancy round are required to join the allocated seat after they are found medically fit by 5 pm on 28-02-2024. If the candidate does not join the allocated seat, the amount of 3 Lakh penalty will be imposed for returning the deposited original documents and no correspondence will be entertained in this regard.
