**Mode of Interview: In-person or through videoconferencing.** The candidates appearing for the interview are required to submit an option in the prescribed form (Annexure 1) regarding the mode of interview to email ID:<[recfacaiimsbilaspur@gmail.com](mailto:recfacaiimsbilaspur@gmail.com)> by 01.04.2022 (Friday), 4.30 PM. Option once exercised shall be final and no request for change will be entertained. Failure to choose an option will be considered as attending the interview physically and no further communication in this regard shall be entertained.

**Certificate Verification:**

(i) **Candidates appearing in-person** shall have to produce the following original certificates for verification and submit one set of self-attested copies at the time of Interview.

1. Birth Certificate or X-Std. Mark Statement (Proof for Date of Birth)
2. UG/PG/Superspeciality degree/PhD Degree Certificates
3. Permanent Medical Registration Certificate from respective Central/State Council (for medical candidates).
4. Registration of Additional Medical Qualification from respective Central/State Council.
5. Caste Certificate – Other Backward Class – Non-Creamy Layer (OBC–NCL)/Schedule Caste (SC)/Schedule Tribe (ST)/EWS (Certificate applicable).
6. If candidate belongs to **OBC category, latest certificate** issued by a competent authority in the prescribed Proforma in accordance with the Government of India, DOPT O.M. No. 36033/28/94-Estt. (Res.), dated 02.07.1997, certifying that the candidate **does not belong to Creamy Layer** mentioned in column No.3 of the schedule to the Govt. of India, Dept. of Personnel & Training, O.M No. 36012/22/93-Estt.(SCT), dated 8.9.1993, will need to be produced.
7. Experience certificate for teaching/research after obtaining the requisite educational qualification to the effect that the same will be treated as teaching/research experience in the concerned discipline.

8. If the candidate is working in Govt./Semi. Govt./Autonomous Bodies/PSUs at present, he/she has to produce an **Original No Objection Certificate from the employer** to the effect that the parent department does not have any objection to his/her applying for the job/to appear for interview for the above said post. Absence of NOC at the time of interview shall render the candidate ineligible for the post.
- (ii) For candidates appearing through videoconferencing, *all original documents mentioned above from SL. No. 1 to 9 have to be submitted for verification along with one set of self-attested copies when asked for before declaration of the results.*
- (iii) All candidates, whether appearing online or in person have to submit the signed scanned pdf of the enclosed Proforma detailing their qualifications, teaching, research and administrative experience by 01.04.2022, 04.30 PM (Annexure 2). The original hard copy to be submitted on the day of the interview.
- (iv) The candidates have to prepare a PowerPoint presentation as per given format (Annexure 3). The same shall be submitted by email along with Annexure 2.
- (v) **CHANGE OF INTERVIEW DATE** is not possible and no such request will be entertained.
