3 x Total posts + Ties (Plus reserved candidates above lowest cut off of UR category).

Note: -

- Candidate to note that the result is merely a list of those candidates who have been shortlisted on the basis of CBT online examination as per the criteria prescribed in the advertisement notice. The Institute has not so far verified the details like age, qualification, experience, skill etc. as required under recruitment rules for the respective posts. Therefore, the inclusion of roll number in the list should not be taken as selection for the above posts. Selection to the posts will be done only amongst eligible candidates on the basis of merit based on total marks obtained in Computer Based online examination.
- The candidates are shortlisted as per the criteria detailed at para 5 (B) of the recruitment notice dated 05/09/2023. Candidates reporting for document verification are advised to read the advertisement carefully, so that they report with the required documents.
- Applications of the shortlisted candidates along with the documents uploaded by them with their online application form will be placed before the Scrutiny Committee for scrutiny of these applications to decide their eligibility. The scrutiny/eligibility will be determined as per the advertisement and the documents submitted by the candidates. DOCUMENT VERIFICATION NOTICE

Subject: - Verification of documents, Group – B & C Posts.

It is notified for the information of all shortlisted candidates that verification of documents to adjudge their eligibility with reference to recruitment rules of the respective posts shall be done on 15/12/2023 on 3rd Floor of Admin Block, AIIMS Bilaspur H.P. w.e.f. 10:30 A.M.

If at any stage during further selection process i.e. documents verification, it comes to the notice that the candidate has filled wrong entries/not qualified as per Recruitment Rules of the post he/she will be treated as Not Eligible and his/her candidature will be treated as cancelled. Therefore, candidates are advised to appear before the committee constituted for verification of original documents on 15/12/2023 at 10:30 A.M. on the 3rd Floor of Admin Block, AIIMS Bilaspur H.P. failing which the candidature of the candidate will be rejected. Shortlisted candidates are advised to bring one set of self-attested documents along with originals as per detail given below:

- (a) Print out of the online Application form.
- (b) Proof of Date of Birth or Class 10th (Matriculation) Certificate.
- (c) Essential Educational Qualification Certificates.
- (d) Essential Professional Qualification Certificates.
- (e) Proof of valid Category Certificate for SC/ST/OBC/EWS.
- (f) Experience Certificates wherever required.
- (g) NOC – Candidates who are currently working with Central/State Govt./ Autonomous Bodies etc.
- (h) Admit Card having Candidate Signature.
- (i) Photo ID Card for proof of identity issued for any Government authority.
- (j) Address proof issued by any Government authority like Electricity Bill, Ration Card, Voter Card etc. as mentioned by him/her in the online application form.
- (k) Any other document in support of candidate's eligibility for the respective post as per recruitment notice/ recruitment rules.
- (l) A candidate who claims change in name after matriculation on marriage or remarriage or divorce etc. the following documents shall be submitted.
 - (a) In case of marriage of women: Photocopy of Husband's passport showing names of spouses or an attested copy of marriage certificate issued by the Registrar of Marriage or an Affidavit from husband and wife along with a joint photograph duly sworn before the Oath Commissioner;
 - (b) In case of re-marriage of women: Divorce Deed/ Death Certificate as the case may be in respect of first spouse; and photocopy of present husband's passport showing names of spouse or an

attested copy of marriage certificate issued by the Registrar of Marriage or an Affidavit form the husband and wife along with joint photograph duly sworn before the Oath Commissioner.

- (c) In case of divorce of women: Certified copy of Divorce Decree and Deed Poll/ Affidavit duly sworn before the Oath Commissioner.
- (d) In other circumstances for the change of name of both male and female: Deed Poll/ Affidavit duly sworn before the Oath Commissioner and paper cuttings of two leading daily newspaper in original (One daily newspaper should be of the area of applicant's permanent and present address or nearby area) and Gazette Notification.
