NOTICE INVITING QUOTATION

Subject: Supply of PICC LINE MANNEQUIN for the Department of Neonatology, AIIMS, Bilaspur (H.P.)

Sealed quotations are invited from registered stockists/distributors/manufacturers having GST No. for supply of PICC LINE MANNEQUIN for the Department of Neonatology, AIIMS Bilaspur (H.P.) as per the detailed specifications (Annexure-A). Sealed Quotations containing both Technical and financial bid separately (In two separate envelopes) duly super scribed at the top of the envelope as "Quotation No. AIIMS-BLS/Neonatology/NIQ/2026/33 for supply of (PICC LINE MANNEQUIN machine) with end date 17-08-2026".

Both the "Technical Bid" and "Financial Bid" may be submitted to reach on or before 17/08/2026 up to 4:00 P.M in Room No 639, Neonatology OPD, B block, 3rd floor, AIIMS Bilaspur, Kothipura, Bilaspur, Himachal Pradesh PIN- 174001. Bidders can quote for either of the items. The financial evaluation will be done item wise separately. Late bids will not be considered. The bids shall be opened in the presence of duly constituted Departmental purchase committee, AIIMS Bilaspur.

Technical Bid Requirement:

For technical evaluation, the bidder is required to submit following documents:

- Profile-Name & Full Address of the firm & year of establishment.
- Copy of permanent GST registration certificate.
- Copies of supply orders secured for the same and similar products.
- Self-declaration that the firm is not debarred by any Govt. Organisation or Department of Commerce.
- Specification compliance undertaking.
- Full description, make and quantity of the item must be mentioned in the quotation.

In case the Technical Committee rejects a sample or the bid is "Not Qualified" on technical grounds, the financial bid in respect of all the items will not be considered.

Financial Bid:

The rates and total cost must be quoted in both words and figures (over writing not allowed). Selection will be made purely on the basis of lowest price quoted by technically qualified firms. Validity of the quotation should be for a minimum period of 90 days. In case discrepancy between unit price & total price, the unit price shall prevail. Financial Evaluation will be based on item wise lowest price (L1) quoted by technically qualified firms.

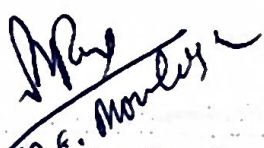
1 PICC LINE MANNEQUIN (For Neonatal use):

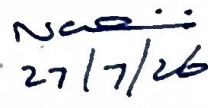

Specifications:

- Should be able to help in central venous catheter skill and needle insertion.
- Should have transparent chest wall and bilateral IV accesses are visible.
- Should have correct anatomical landmarks: basilic vein, cephalic vein, jugular vein, subclavian vein, and superior vena cava.
- Should be made of special material which should be soft, flexible, and easy to wash.
- Should have visible ribs and heart which allow measuring correct inserted length of catheter.
- Superior vena cava should be transparent.
- Warranty for 2 years at least.
